EXPERIENCE STANDARDS REQUIRED TO OBTAIN A PLUMBING CERTIFICATION IN NEVADA

Journeyman Experience

Nevada Board of Plumbing Examiners (NBOPE) requires a journeyman to possess a minimum of four (4) years in a state registered, accredited apprenticeship program or eight thousand (8,000) hours of substantiated experience in the plumbing trade to obtain a Nevada Journeyman Certification.

Master Plumber Experience

NBOPE requires a master plumber to possess a minimum of four (4) years in a state registered, accredited apprenticeship program or eight thousand (8,000) hours of substantiated experience in the plumbing trade <u>and</u> one (1) year or two thousand (2,000) hours of maintaining a current Nevada Journeyman Certification to obtain a Nevada Master Plumber Certification.

VERIFYING REQUIRED EXPERIENCE TO OBTAIN A PLUMBING CERTIFICATION IN NEVADA

All applicants are required to provide proof of employment in the plumbing industry, and as such, this affidavit enables applicants to verify the minimum required experience needed to take the Journeyman or Master Plumber Certification Exam. The following verification must be completed by a current or previous plumbing contractor employer:
