The certification exams for both journeymen and master plumbers assess the applicant's understanding and expertise of the 2018 Uniform Plumbing Code (UPC) with fifty (50) open-book questions and one hundred (100) closed-book questions.

Computer Exam

The cost to take the exam by computer is one hundred twenty-five dollars (\$125) along with an additional ninety-dollar (\$90) processing fee. Exams by computer will be conducted at a Prometric Test Center. Exams given at a Prometric Test Center require an email address, therefore, please ensure an email is provided below. An e-mail confirmation will be sent along with login information to schedule the exam.

Applicants may cancel or reschedule thirty (30) days prior to the scheduled test date without penalty. Applicants may cancel or reschedule within 5 to 29 days prior to the scheduled test date with a thirty-five-dollar (\$35) penalty. Applicants may cancel or reschedule less than five (5) days prior to the scheduled test date with a fifty-dollar (\$50) penalty and must contact the National Inspection Testing and Certification Corporation (NITC) to obtain new eligibility.

Paper Exam

EXPERIENCE STANDARDS REQUIRED TO OBTAIN A PLUMBING CERTIFICATION IN NEVADA

Journeyman Experience

Nevada Board of Plumbing Examiners (NBOPE) requires a journeyman to possess a minimum of four (4) years in a state registered, accredited apprenticeship program or eight thousand (8,000) hours of substantiated experience in the plumbing trade to obtain a Nevada Journeyman Certification.

Master Plumber Experience

NBOPE requires a master plumber to possess a minimum of four (4) years in a state registered, accredited apprenticeship program or eight thousand (8,000) hours of substantiated experience in the plumbing trade and one (1) year or two thousand (2,000) hours of maintaining a current Nevada Journeyman Certification to obtain a Nevada Master Plumber Certification.

VERIFYING REQUIRED EXPERIENCE TO OBTAIN A PLUMBING CERTIFICATION IN NEVADA

All applicants are required to provide proof of employment in the plumbing industry, and as such, this affidavit enables applicants to verify the minimum required experience needed to take the Journeyman or Master Plumber Certification Exam. The following verification must be completed by a current or previous plumbing contractor employer:
